



Sonoma County Women Soccer League Waiver of Liability and Release

For and in consideration of the undersigned participant's registration with Sonoma County Women's Soccer League, (SCWSL) and being allowed to participate in events and member activities, participant hereby waives, releases, and relinquishes any and all claims for liability and cause(s) of action, including for personal injury, property damage, or wrongful death occurring to participant or arising out of participation in events, or sports, and/or activities incidental thereto, whenever or however they occur and for such period said activities may continue, and by this agreement any such claims, rights, and causes of action that participant may have are hereby waived, released and relinquished, and participant does so on behalf of their heirs, executors, administrators and assigns.

Participant acknowledges, understands and assumes all risk relating to events or sports participation and activities incidental thereto, and understands that activities incidental thereto involve risks to participant's person including bodily injury, partial or total disability, paralysis, and death and damages which may arise there from and Participant has full knowledge of said risks. These risks and dangers may be caused by the negligence of the participant, negligence of others, including the organization, its affiliates, members, event hosts, other participants, other parents and legal guardians, coaches, officials, sponsors, advertisers, owners and operators of the premises used to conduct any event and each of them, their officers, directors, agents, and employees (collectively, "releasees") and include risks arising from the conditions and use of facilities and related premises. Participant further acknowledges that there may be risks and dangers not known to participant or not reasonably foreseeable at this time.

Participant acknowledges, understands and assume the risks, if any, arising from the conditions and use of facilities and related premises, whether as a participant or a spectator, including without limitations, the risks involved with participating in SCWSL activities. Participant further acknowledges and understands that included within the scope of this waiver and release is any cause of action (including any cause of action based on negligence) arising from the performance, or failure to perform, maintenance, inspection, supervision or control of said areas and for the failure to warn of dangerous conditions existing at said facilities, for negligent selection of certain releases, or negligent supervision or instruction by releases.

Participant acknowledges, understands and assumes the risk relating to possible exposure to illness from infectious diseases including but not limited to Covid-19, and acknowledges the risk that serious illness and death does exist. Participant knowingly and freely assumes all such risks, both known and unknown, even if arising from the negligence of the releasees or others and assumes full responsibility for their participation; and agrees on behalf of themselves and any heirs, assigns, personal representatives and next of kin, to release and hold harmless SCWSL, and their officers, officials, agents, and/or employees, other participants, and the owners and lessors of premises used to conduct the event ("Releasees"), with respect to any

and all illness, disability, death, or loss or damage to person or property, whether arising from the negligence of releasees or otherwise, to the fullest extent permitted by law.

Participant agrees to immediately inform SCWSL in writing at scwslpres@gmail.com if they have been infected with COVID-19 during the playing season, which in turn exposed or potentially exposed other players during a SCWSL scheduled game. Participants are required to follow local Sonoma County guidelines regarding quarantining after being infected with or exposed to COVID-19.

Participant agrees if any claim for personal injury or wrongful death is commenced against releasees, he/she shall defend, indemnify and save harmless from any and all claims or causes of action by whomever or wherever made or presented for his/her personal injuries, property damage or wrongful death.

Participant acknowledges and understands SCWSL reserves the right to photograph facilities, activities and program participants for potential future use. All photos remain the property of SCWSL and may be used for publicity and promotional services.

Participant acknowledges that they have been provided and have read the above paragraphs and have not relied upon any representations of releasees, that they are fully advised of the potential dangers and risks and understand these waivers and releases are necessary to allow the activities of SCWSL to exist in its present form.
